

Proposal of Treasurer to amend Tournament Registration Fees

Changes are in bold

Old Regulation

Registration Fees for Organization of Tournaments

- 12.1 Registration fees will be charged annually to the national federations in whose territories registered international chess competitions are held.
- 12.2 The registration fee is calculated on the following basis:

|------------------------------------|----------|
| Tournaments of categories 0 to 3: | 30 Euro |
| Tournaments of categories 4 and 5: | 60 Euro |
| Tournaments of categories 6 and 7: | 90 Euro |
| Tournaments of categories 8 to 10: | 120 Euro |
- Other categories - multiply 30 Euro by the category.
- Swiss Tournaments: Number of players multiplied by 1 Euro
Team Tournaments: 1 Euro per player, no maximum
Matches: according to category above.
Scheveningen Tournaments: shall be charged as team event.
- 12.3 The annual tournament registration fees payable by a federation shall be a maximum of 5200 Euro. Any late report service charges shall be in addition to the maximum.
- 12.4 A federation that fails to submit a rating report of a registered event in accordance with Title Regulation 1.9, B.01, shall be charged a penalty fee of 70 Euros for each offence, over and above the chargeable rating fee where more than 20% of the reports submitted in a six month period are concerned.
- 12.5 Tournaments submitted for rating by non-service federations shall be returned to the federation. There will be a delay of three months from the time a federation no longer receives service to the implementation of this regulation.

New Proposal

Registration Fees for Organization of Tournaments

- 12.1 Registration fees will be charged annually to the national federations in whose territories registered international chess competitions are held.

| Tournaments of categories 4 to 7: | 100 Euro |
| Tournaments of categories 8 to 10: | 150 Euro |
| Tournaments of categories 11 to 14 | 200 Euro |
| Tournaments of categories 15+ | 300 Euro |
- Swiss Tournaments: Number of players multiplied by 1 Euro
Team Tournaments: 1 Euro per player, no maximum
Matches: according to category above.
Scheveningen Tournaments: shall be charged as team event.
- 12.3 The annual tournament registration fees payable by a federation shall be a maximum of **15,000 Euro**. Any late report service charges shall be in addition to the maximum.
- 12.4 A federation that fails to submit a rating report of a registered event in accordance with Title Regulation 1.9, B.01, shall be charged a penalty fee of 70 Euros for each offence, over and above the chargeable rating fee where more than 20% of the reports submitted in a six month period are concerned.
- 12.5 Tournaments submitted for rating by non-service federations shall be returned to the federation. There will be a delay of three months from the time a federation no longer receives service to the implementation of this regulation.
