Report

Meeting of FTC was divided into 2 parts. 1t part was held in Heraklion during European Championship. 2-d part was held in Antalya.

Meeting in Heralion

Members present: Y.Razuvaev (Chairman), A.Mihalcishin (Vice-Chairman), U.Boensch (director of Berlin FIDE Trainers Academy), E.Grivas, S.Lputian, A.Petrosian, V.Tukmakov, V.Jansa. Invited: Vice-President Mr.Borg.

1. Report of chairman.

Yuri Razuvaev evaluated activities of FTC since last meeting.

- a)Berlin Academy is working well, but New York American University faces certain problems.
- b) system of licenses doesn't work at all.
- c) a big group of trainers, who successfully passed through seminars didn't received FIDE certificates. Chairman's report was approved.
- 2.Problems with manual for trainers aren't solved up to now, but in last few months appeared some possibilities to start this the most important for all trainers project.
- 3.GM Boensch suggested to start a new licenses process. A reason-4 years passed since we began.
- 4.GM Mihalcishin reported about a concept of the live- trainer in internet and DVD. He underlined that such system gives to all the countries opportunities to live- contact with best trainers of the world.
- 5. Vice-president Mr.Geoffrey Borg indicated how important to make a real business plans for every proposal. He appealed to wide the activity of Academies, to include arbiters, organizers and children into educational process.

Propositions of FTC

To create a group of experts for writing the manuals.

FIDE Trainers system should be combined with international system of sport organizations, as Olympic Committees of native countries and Sport Ministries. To prepare 2 letters:1) to International Olympic Committee; 2) to European Union sport body.

To recognize Berlin FIDE Trainers Academy as a center for scientific activity in the trainer's field.

To prepare all documents and software materials to begin FIDE Trainers Education on line. FTC suggests a system of double responsibilities (FTC and national federations) to conduct this educational process.

To change the position of FTC inside FIDE for realization of manual's and education on line projects; to put FTC under direct supervision of President or Deputy President.

To establish system of FIDE medals and prizes for the best trainers in different categories. GM Mihalcishin reminded that FIDE establish such awards in 1988 but no medals ever were given.

To create a system of training stages on line in FIDE Trainers Academies. To improve cooperation of FTC with Chess base and Chess Assistant.

- 1.Report of chairman was approved. All proposals of Heraklion meeting were included in agenda.
- 2. Situation around trainer's titles was discussed. Many candidates for the titles who successfully passed trough FIDE Academies seminars still didn't get FIDE certificates. Such situation was recognized unacceptable and Genaral Secretary

Mr. Leong informed the meeting about the coming measures of quick improvement. Trainers Committee pointed out once again that system of licenses still didn't start and this fact put the activity of FIDE Academies in a difficult position. Mr.Leong informed Committee that a system of licenses will start in 2008 and FIDE Academies will get the rights to award successful candidates with licenses at the end seminars.

3. FTC again repeated a high priority of Manual project in it's activity. Trainers Committee approved proposal of Heraklion meeting about foundation of editorial committee of new manual edition and Experts Council for certificating

Educational and Training programmes

4.FTC realized that successful development of children movement demands a great a number of trainers and teachers of FIDE Instructor level. Such problem can be solved only with using of modern high technology. FTC approved Heraklion proposal to create a new system of FIDE Academies on line. FTC received proposals from Berlin FIDE Trainers Academy and RGSU Moscow about start of the project. Chairmen of 5 commissions and committees supported the proposal about on line FIDE Academies.

5.FTC approved a proposal of GM Adrian Michalcishin to establish a system of FIDE medals and prizes for the best trainers of the world in different categories.

6. FTC ask a member of the committee Mr. Bolat Asanov to contact with IOC and EU on questions of co operations in trainers and educational activities.

7.FTG ask chairman to prepare a new list of members for the next PB according to new regulations.
