Report of Independent Public Accountants

To the President and Members of the **Fédération Internationale des Echecs**

We have audited the accompanying financial statements of Fédération Internationale des Echecs (The 'Federation') – a non profit federation, consisting of a balance sheet, statement of activities and Notes, for the year ended December 31, 2005.

These financial statements are the responsibility of the Federation's management. Our responsibility is to express an opinion on these financial statements based on our audit.

Our audit was conducted in accordance with International Auditing Standards. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement. An audit includes examining on a test basis, evidence supporting the amounts and disclosures in the financial statements. NOTES TO THE FINANCIAL STATEMENTS AS AT DECEMBER 31, 2005 (All amounts in CHF)

1. FEDERATION'S FORMATION AND OPERATIONS

The International Chess Federation or Federation Internationale des Echecs, (the 'Federation'), is the recognized international federation in the domain of chess, which was founded on July 20, 1924 in Paris. The Federation is recognized by the International Olympic Committee as the supreme body responsible for the game of chess and its Championships. The Federation unites national chess federations throughout the world and oversees all International competitions. The Federation is concerned exclusively with chess activities.

In 2004, the Federation's secretariat in Lausanne was closed and transferred to Athens, 9 Syngrou Avenue - Greece.

2. BASIS OF FINANCIAL STATEMENTS

The accompanying financial statements have been prepared in accordance with the requirements of the Federation's statutes.

The financial statements have been prepared on the historical cost basis.

3. SIGNIFICANT ACCOUNTING POLICIES

(a) **Foreign currency translation:** The Federation's functional currency is the Swiss Franc (CHF). Transactions denominated in other currencies are recorded in CHF at the actual exchange rate as of the date of the transaction. At the end of financial year monetary assets and liabilities denominated in foreign currencies are translated and reported at the rates of exchange prevailing at the year end. Gains or losses resulting from foreign currency conversions are reflected in the statement of income. All foreign currencies are converted into CHF as follows:

- (b) **Provisions:** Debtors are stated at nominal value, net of provision for doubtful debts, which covers all members in arrears in fulfillment of their financial obligations to FIDE, temporarily excluded or to be excluded as per FIDE statutes (A.01, page 4, rule 2.5). In 2005 in particular provision against Royalties receivable from DGT, the company producing electronic clocks, was set up for the first time covering the unpaid balance at year end.
- (c) **Inventories:** Stocks of medals have been written down to zero from a nominal value of CHF 1 last year as they have no intrinsic value outside FIDE.
- (d) **Fixed assets depreciation:** Depreciation rate used is 30% per annum on acquisition cost.

(e) **Revenue recognition:** Membership, entry and other fees are recorded as income in the year they are earned.

4. Prior years' income

During 2004 amounts aggregating CHF 604,045 were collected and recorded as income of 2004, as they were expensed in previous years as described in the Treasurer's report to the General Assembly that approved the 2003 financial statements.

5. Bank accounts

Until last year a USB US dollar account that is held on behalf of the Americas was included in both Bank accounts and Creditors. This year the balance of this account of CHF 22.449 (2004 – CHF 2.157) has been eliminated from Bank accounts and Creditors.
