- 3.2.1. Can directly register its trainees (maximum two players per category wild cards) to World Youth and World and Continental School Championships.

- 3.2.3. Can resell 'FIDE Official Books' and 'FIDE Trainers' Syllabus' up to +100% above cost.
- 3.2.4. Can organize official FIDE Training Camps.
- 3.2.5. Can issue FIDE official attendance certificates.
- 3.2.6. Can propose its best student for the FIDE Candidate Master title (once per year).

Dear Mr Mikhalchishin and Mr. Grivas,

The email is the official response to your request for the USCF official position on the subject and reasons of rejection of Mr. Sevan Muradian's application to USCF for a FIDE Academy.

The "FIDE Academy" gives powers reserved for National Federations to FIDE Academies. Therefore USCF has rejected the application for a FIDE academy from Mr. Muradian.

Furthermore, the board has voted that the USCF create a FIDE Academy in the US to support seminars and other activities without relinquishing the rights of a national federation. Once the USCF Academy is established, Mr. Muradian can apply to USCF to hold seminars under the auspices of the USCF's FIDE Academy.

I would also like to remind the Commission of the correspondence of 27 November 2012 about FIDE academies from Mr. Grivas to Mr. Freeman which was forwarded to Mr. Vega and myself.

In the first paragraph it is stated, "And at any time this approval can be revoked by the federation due to various (logical) reasons. So, the federations are truly respected in this manner."...

In the third paragraph of that letter it is stated, "All in all to conclude with, the national federation has full power over its Academies, when logical restrictions are on"....

Please be advised of the two motions below passed by the USCF board on February 4th 2013:

The Board moves that because the authority outlined for FIDE academies would grant them powers that have long been reserved for national federations, the USCF does not approve the application for a FIDE academy made by Sevan Muradian.

The Board moves that because the authority outlined for FIDE academies would grant them powers that have long been reserved for national federations, the USCF will establish any future FIDE academy in the United States. The Executive Board directs the Executive Director to develop a plan to establish such an academy for review and approval at the May EB meeting.

## **Subject: North Shore Chess Center FIDE Academy Application**

Dear Mr. President,

TRG received an appeal by Mr. Sevan Muradian, concerning a rejected FIDE Academy Application made to the USCF (09.12.2013), according to the regulated procedure. The TRG Board asked the official position of the USCF on the matter, which was kindly sent on 24.02.2013. All three documents are attached.

TRG Council examined the subject and decided to recommend to the PB to approve the 'North Shore Chess Center' application, on the following reasons:

- 1. The Academies' Regulations were approved by the FIDE GA and have to be followed by all federations. Here we have a case where a federation is declining to follow the approved regulations stating that it doesn't agree with them no other reason.
- 2. Rights for the federations have been reserved in the past but according to the new regulations Academies have rights as well, which must as well be respected.
- 3. Of course at any time the approval of the federation can be revoked due to various (logical) reasons, but here we have an unlogical reason of rejection at the very first, before it was even approved. So, the federations are truly respected in this manner, but they should follow the GA and PB decisions.
- 4. There is already one approved TRG Academy according to FIDE/TRG regulations in USCF, the 'American Chess Academy' run by M.Khodarkovsky. This creates a conflict already and it doesn't make sense to reject a new application which wishes to operate under exactly the same rights and obligations. But of course it must be noted that the ACA is one of the three original FIDE Academies established back in 2005, where the regulations were different.

Note that TRG Board Councilor M.Khodarkovsky wished to remain neutral on this subject for obvious reasons. All other four Councilors (A.Mikhalchishin, E.Grivas, U.Boensch and J.Petronic), shared the present recommendation.

At the last PB, the FIDE Trainers' Commission, unanimously recommended (Khodarkovsky remaining silent) that FIDE should accept the North Shore Center FIDE Academy Application, as the USCF rationale for refusal was not acceptable.

The PB decided, before accepting their recommendation, that we should write to you again on this matter, requesting a clearer rationale.

We note that you say that the "board has voted that the USCF create a FIDE Academy in the US" and that once this "Academy is established, Mr Muradian can apply to USCF to hold seminars...." Are we correct that in these circumstances, Mr Khodarkovsky's Academy will also no longer be a FIDE Academy and he would have to apply to USCF to hold seminars?

Dear Nigel, Presidential Board and Trainers' Commission members,

The USCF's rationale for not approving the FIDE academy application submitted by Mr. Muradian remains the same, as documented in my letter of 2/24/2013 to the Trainers' Commission. The approval of a FIDE Academy results in the granting of powers that have long been reserved for national federations to the FIDE Academy. For this reason, USCF did not approve Mr. Muradian's application.

USCF is very disappointed with the FIDE Trainers' Commission recommendation to the Presidential Board regarding Mr. Muradian's appeal. In our recent correspondence we were assured by the Trainers' Commission that national federations will be respected and have full power over the FIDE Academy process in our respective countries.

As you also know, American Chess University (ACU) was approved in 2005 by FIDE along with the Berlin and Singapore FIDE Academies. These academies were grandfathered by FIDE when rules were changed in 2012 Congress in Istanbul.

USCF has an agreement with American Chess University which provides that ACU will only hold Trainers' seminars when approved and coordinated with the USCF office at our key events. In fact, all seminars held by American Chess University have been sanctioned by USCF and held in conjunction with major USCF events.

Currently, Mr. Muradian can apply to the USCF office for approval to hold a FIDE trainers' seminar. Provided the event details and arrangements meet the requirements outlined by the FIDE Trainers' Commission for conducting a Trainers' Seminar and provided the event is not in conflict with another FIDE Trainers' Seminar already scheduled in the same geographic area, Mr. Muradian and others who might want to organize a Trainers' Seminar can expect due consideration from the USCF office.

Regarding American Chess University: As I previously stated, ACU only holds trainers' seminars which are approved and coordinated with USCF. So to answer part of your question, Yes, American Chess University has to apply to USCF to get approval to hold a trainers' seminar.

Regarding the other part of the question, I assume you are asking if USCF will revoke American Chess University's status as a FIDE academy? The board has not considered this question because the agreement with The American Chess University academy is for trainers' seminars only, and based on the 2005 definition of a FIDE Academy. Because of this agreement, American Chess University has no special rights that would normally be reserved for national federations, and does not operate as a FIDE Academy as currently defined by FIDE per Istanbul 2012 changes. If the American Chess University academy were to breach the agreement with USCF, the

board would take appropriate action. At this time we have no reason to revoke ACU's FIDE academy status.

#### Dear Ms. President,

The Trainers' Commission's recommendation to the last FIDE PB was strictly based on the current active Regulations, which were approved in the 2011 FIDE Congress in Krakow. According to these Regulations the rights that were long preserved for federations (as you are quoting) are not belonging any more strictly to federations and FIDE Academies can have their own share as well if they wish so. This is a fact, which the USCF continuously ignores in its letters concerning the case in question.

If you do not agree with the decisions and the opinion of the majority of the federations that voted positively for the changes, you are welcomed to propose changes to the next FIDE Congress. But until then we feel that at least the FIDE Trainers' Commission should respect and follow strictly these Regulations.

We did assured you (Trainers' Commission) that national federations will be respected and have full power over the FIDE Academy process in the respective countries and we mean it. But we never promised that we will overlook the FIDE regulations and our recommendation remains the same, as your rejection of the North Shore CA application is based on Regulations that are not anymore valid - they have been replaced and this is what we are trying to explain you.

As for your personal agreements with the ACU, we have no comments, as this is an internal affair.

We hope that you understand that our actions are based on the FIDE Regulations and we do wish to get involved in anything else out of it.

#### Dear Mr. Grivas,

Thank you for your quick reply. I assure you that USCF is not ignoring the TRG Rules and Guidelines which apply to officially endorsed FIDE academies. As you have noted, FIDE Academies have certain rights which apply to officially endorsed academies. The academy in question has not been endorsed by the national federation, USCF. If we had endorsed the academy, then we would be in agreement about the duties and privileges of the academy.

the "FIDE Academy Official Application" it On is required that the applicant apply for and receive the endorsement of the National Chess Federation, and the application has a section called "Endorsed by National Federation". Mr. Muradian applied to USCF for endorsement. The USCF Executive Board met and considered Mr. Muradian's application and decided NOT to endorse the North Shore Academy. We had a long discussion of the matter and their were several factors in play not discussed in our correspondence with FIDE. USCF has been assured many times that FIDE will respect the authority of the national federations and that the national federations will have full power over the FIDE academy process in their respective country. This does not seem to be true in practice, however. Has FIDE made changes to the TRG Rules and Guidelines for **FIDE** Academies to remove the requirement for an endorsed

FIDE Academy to get the endorsement from the National Federation? Where is it written in the Rules and Guidelines that TRG will judge the reason for approval or denial of an application made by a national federation?

I am disappointed that we cannot agree on the the simplest of questions about the TRG Rules and Guidelines governing the FIDE Academies, and how those rules and guidelines apply in this instance.

Since such a basic question has arisen, over whether national federations' endorsement is required to start an "Endorsed FIDE Academy", I suggest Trainer's Commission do review that the a complete the FIDE Academy Rules and Guidelines to clarify them so that there will be no questions of such a major nature in the future.

I am awaiting your response or further questions with regards to this matter.

#### Dear Ms. President,

There is nothing to add in the Regulations or in the TRG's approach on contact with the federations - all are absolutely clear, fair and respected. And of course the endorsement of the national federation is obligatory. The problem in the case of the North Shore CA is that USCF rejected its application on grounds that are not in accordance with the regulations. And because of this clear mistake (for TRG at least) Mr. Muradian appealed to TRG and FIDE.

A federation can accept or reject an Academy application on legal or any other reason that is fair and acceptable on logical grounds but cannot do it with reasons that are controversial with the FIDE Regulations. In your previous letters to FIDE and TRG you didn't state any other reasons of rejection but simply reasons that are not acceptable, as they are not in line with the Regulations. You have power over Academies in your region, but also the Academies-to-be have the right to appeal and ask for a more 'fair' examination (in their opinion). And TRG accepted the NNCA appeal, because of your 'clear mistake' (at least for us) as we stated above.

We would kindly suggest re-examining the North Shore CA application, forgetting the reasons that you have rejected it by now. And maybe, you can also come to the same agreement as you did with the ACU of M. Khodarkovsky (who by the way proposed and created the most of the Regulations in the Academies).

FIDE and TRG would like to see more FIDE Academies coming-up in every country, operating in harmony with the national federations and we do not see any reason to get involved in so many controversials and disagreements.
